CHN's Developmental Support Program



According to the CDC, one in 36 children are diagnosed with autism spectrum disorder (ASD), which occurs in all racial, ethnic, and socioeconomic groups and according to a recent article posted on Adoption.com, "children with autism are 2.4 times more likely to enter foster care" than children without the ASD diagnosis. As a leader in child welfare and residential services, CHN saw firsthand the increasing number of children with autism spectrum disorder entering foster care along with a significant lack of resources to assist the children and their foster families. Due to the understandable challenge for foster parents, the child may struggle with the adjustment to foster care. This struggle can lead to a child with ASD coming into our care.

Growing to meet the community's changing needs, CHN implemented an Applied Behavior Analysis (ABA) Program in 2015 - a notable treatment for people with ASD which works to increase acquisition of skills in a variety of areas and to decrease behaviors that may be unsafe or harmful. Having the capacity to expand to meet the needs of those we serve is all thanks to our supporters like you. Furthermore, because of our generous donors, in September of 2022, CHN's Kids Village Developmental Support Program was opened. This new initiative, located on our main campus in Tampa, serves youth with developmental needs or ASD who reside in a healing cottage.

One story about a child living on our campus that shows the importance and impact of the Developmental Support Program Cottage since its opening is Rosie's. Rosie is a 13-year-old girl who came into foster care when her mother was hospitalized due to mental health issues. Rosie is a delightful child with a beautiful smile and engaging laugh. She is also non-verbal, struggled to manage sensory experiences in her new foster home, needed help using the bathroom and was unable to express her fears or the fact that she missed her mother. It was soon learned that caring for a child with profound autism created significant stress for Rosie's mother and as a result, she neglected her own mental health needs. It would be a long road for Rosie's mom to become stable and be ready to parent her daughter again.

CHN's Developmental Support Program is designed to ensure that the boys and girls have the necessary sensory tools readily accessible to help them regulate, reduce their anxiety, and communicate. This created a soothing environment for Rosie, and she immediately found a favorite blanket and a special toy that she always kept with her. This behavior is common for children and teens with ASD, as they can be very intense and focused on their favorite toys and activities. More recently, another common behavior for individuals with ASD surfaced for Rosie as she began removing her clothing in public areas. Children with ASD struggle with tactile stimulation and the confinement of regular clothing. Unlike non-ASD children, Rosie was unaware of expectations and social cues and norms.

Immediate attention and redirection were needed to help Rosie understand safety and social expectations. CHN's ABA and dedicated caregiver team developed a plan for Rosie that modified her wardrobe to loose fitting, more comfortable clothing, reinforced that her room was her safe, private space, and lined her windows to protect her privacy so children outside the cottage could not see in her room. CHN is grateful

to be able to provide this heightened attention to detail and to have the ability to hire and train specialized staff, which is exactly what sweet Rosie needed.

Rosie quickly responded to the team's care, prompts, encouragement, and reinforcements. She learned that if she wanted to take her clothes off, she could do so alone in her room with the door closed. Additionally, although Rosie is non-verbal, she is bright and learned to communicate her needs with staff and participate in outings and social events, including finding a best buddy in the cottage. CHN's staff are committed to thinking outside the box when meeting a need and they have done an amazing job with Rosie on her journey. These life improving services are all thanks to our generous supporters.

During the time that she has been living in the Developmental Support Cottage at CHN, Rosie regularly visited her mother and there was much hope and anticipation that they would be reunified before school started. CHN worked closely with her mother, teaching her techniques and skills to better manage Rosie at home. Unfortunately, mental health is a fragile thing, and one week before reunification was to take place, Rosie's mom, through no fault of her own, had to be hospitalized again. CHN will continue to support Rosie and her mom and is committed to the family unit. We will stay the course with them until Rosie gets to go home or to another permanent and nurturing living situation and we will continue to provide her with the safety, care and support she deserves.

CHN is proud to provide the specialized interventions, tools and programming that are necessary to effectively support and serve boys and girls with ASD. Your generosity ensures that the home has appropriate furnishings, sensory items, medical and adaptive equipment, and technology tools to assist our children as they learn, grow, and succeed. At CHN, we believe that every child should feel lovable, capable, and worthwhile and thanks to you, we are able to help children like Rosie realize the beauty about themselves each day.



The Children's Home Network main campus in Tampa, FL is the site of our residential treatment and healing program for children ages 6-17 supporting children healing from abuse, neglect and abandonment.

RAISE

(Reaching and Inspiring Students Everywhere) Intervention program that works collaboratively with families and the community to ensure children from birth through 3rd grade and their families receive services to meet their needs and promote positive educational outcomes

Kinship

Who we serve

Fostering Families

Our program is exclusively committed to recruiting, preparing, and supporting foster families to nurture children and mentor the families as a whole. We strive to keep siblings together, while providing safety and permanency through reunification and family restoration.

Pinellas Support Team

Behavioral health and tutoring program providing services to families residing in Pinellas County with children in pre-kindergarten through high school.

Caregiver Support Services

The program serves children between the ages of 0-13 who have physical disabilities, social-emotional challenges, or developmental delays/disabilities and caregivers who are experiencing acute situational stressors leading to a strained family system. The program works to reduce household stress through "respite" or short-term childcare services.

Healthy Families Hillsborough (HFH)

Nationally accredited home visiting program for expectant parents and parents of newborns experiencing stressful life situations. HFH improves childhood outcomes and increases family self-sufficiency by empowering parents through education and support.


